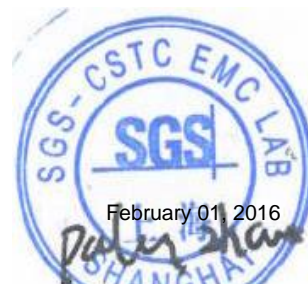
### Conclusion
