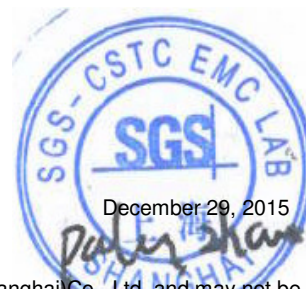
Conclusion
